5. I acknowledge that I may be photographed or videotaped during the Activity. I hereby consent to the use of these photographs and/or videos without compensation, on all or any of the following:

7. I understand that the University Social Club and the Activity is conducted by members of the University Social Club who are unpaid volunteers.
8. I understand that should my contact details change after my registration is completed, it is my responsibility to notify the University.
