# Bachelor of Laws (Graduate Entry)

This world-class degree is now available to study at UOW's Sydney CBD campus, situated at the upmarket end of Sydney's CBD on Sydney Harbour. The [Bachelor of Laws \(Graduate Entry\)](#) provides a thorough grounding in the law, as well as a real-world focus on the essential practical skills and the social and ethical context in which the law operates. It is available to graduates of disciplines other than law, and to graduates of law degrees from outside Australia.

This three-year full-time degree (or part-time equivalent) covers the prescribed areas of knowledge for future admission to the profession, as well as a choice of electives. Additionally, an integrated skills program equips graduates with experience in areas such as legal research, interviewing, legal drafting, advocacy and negotiation.

## FLEXIBLE STUDY

To fit in with your personal and professional commitments, the Bachelor of Laws (Graduate Entry) can be studied full-time or part-time.

Your classes are offered after 5:30pm, and as a student of the Sydney CBD campus, you will have access to the facilities for additional study time including evenings and Saturdays.

## SYDNEY CBD CAMPUS

Our [Sydney CBD campus](#) is located at the upmarket end of Sydney's Central Business District (CBD) on Sydney Harbour. It overlooks both the Opera House and Sydney Harbour Bridge and is well serviced by buses, trains, light rail and ferries. The campus runs across three levels of the Gateway Building in Macquarie Place and boasts state of the art teaching and learning facilities, including: a dedicated library, computer labs, student breakout rooms, a student lounge with kitchen facilities, student services and support desk, prayer room, parent's room, and a large outdoor balcony for students to take in the view.



## ENTRY REQUIREMENTS

To be eligible for admission into this degree you need to have completed an undergraduate degree. The UOW School of Law requires a minimum average mark of 70% (or GPA/WAM equivalent). If an applicant has a mark that is lower, then the school may consider other factors such as:

- The nature of any previous course of study and the subjects undertaken therein.
- Relevant professional experience.
- Any personal statement provided by the applicant.

## FEES

Domestic students of the Bachelor of Laws (Graduate Entry) are eligible for a Commonwealth Supported Place (CSP). This means you will benefit from the Australian Government contributing financially towards your degree. On average, the Australian Government contributes up to 75% of the total tuition fee for CSP students. Students are then responsible for the balance of the fees. This is known as 'student contribution'. This contribution is dependent on the subjects you take, and the year in which you complete them.

You will also be able to defer your payments while at uni with a HECS-HELP loan. This loan allows students to defer their student contribution until a government determined income threshold is met.

## REAL-WORLD EXPERIENCE

As a UOW Law student, you will be required to do a 20 day [internship](#) as part of your studies, so you can apply your legal knowledge to real-life situations. UOW is the only university in NSW to require this experience.
