FUNDING MODEL - FREQUENTLY ASKED QUESTIONS (FAQS)

What is the funding model?

In 2021 the Summer Master Class (SMC) program changed from a 2-tiered admission fee structure to a 3-tiered fee structure. This 3-tiered structure will remain in place for the 2023 iteration of Summer Master Classes.

See below details of the **Sponsorship Model** with 3 tiers of admission fees.

(Please Note: There are a limited number of full and partial sponsorships available under Tier 2 and Tier 3. Students will be eligible to be considered for these sponsorships based on the below, and will have the opportunity to apply for sponsorship in their SMC application)

Tier 1) Full Fee Paying Admission- \$480

Students who **DO NOT** meet any of the sponsorship criteria below

Tier 2) Half Fee Paying Admission (50%) discount- \$240

Students who meet **ONE** of the sponsorship criteria below:

- Attending an In2Uni Sponsored School in Year 12
- Student/ parents are in receipt of a Centrelink (or other Commonwealth) means-tested income support payment or COVID related job seeker or job keeper payment*
- Australian Aboriginal or Torres Strait Islander
- Experiencing social disadvantage or financial hardships which may impact on your ability to participate in the program without some financial assistance*
- Have a diagnosed disability or medical condition; including mental health conditions*
- Attend a rural or remote classified school
- Refugee Status*
**Evidence to be included with application*

Tier 3) Full Sponsored Admission - \$0

Students who meet **TWO** or more of the sponsorship criteria below:

- Attending an In2Uni Sponsored School in Year 12
- Student/ parents are in receipt of a Centrelink (or other Commonwealth) means-tested income support payment*
- Australian Aboriginal or Torres Strait Islander
- Experiencing social disadvantage or financial hardships which may impact on your ability to participate in the program without some financial assistance*
- Have a diagnosed disability or medical condition; including mental health conditions*
- Attend a rural or remote classified school
- Refugee Status*
