



University of Wollongong Spring/Trimester 3 Subject Evaluation by Students (SEBS) Survey and Teacher Evaluation by Students (TEBS) Promotion – Terms and Conditions

Entry into the University of Spring/Trimester 3 Subject Evaluation by Students (SEBS) Survey and Teacher Evaluation by Students (TEBS) Promotion (**Promotion**) is deemed to be an acceptance of the following Terms and Conditions. Entries must comply with these Terms and Conditions to be valid.

1. **Promoter:** The Promoter is University of Wollongong (ABN 61 060 567 686) of Northfields Avenue, Wollongong, NSW 2522 (**UOW**).
2. **Promotion Period:** This Promotion will run from Monday 18th September 2023 at 12:00am AEST to Sunday 26th November 2023 at 11:59pm AEST.
3. **Who can enter:** Eligible persons include any UOW student who enrolled during the Promotion Period in an onshore UOW subject that is being evaluated during the Promotion Period (**Entrant**). The Promoter's directors, management, employees and their immediate families are ineligible to enter.
4. **How to enter:** To enter the Promotion, the Entrant must, during the Promotion Period, complete a Subject Evaluation by Students (SEBS) survey or a Teacher Evaluation by Students (TEBS) survey, which will be made available to entrants via a link sent to their UOW email address.
5. **How many times can you enter:** For every survey completed the Entrant will receive one entry.
6. **Winner selections:** The winners of the prizes will be chosen at random out of the pool of eligible entrants who have entered the Promotion in the valid form. Winner selections will be held at the Promoter's Academic and Quality Standards Unit, Building 36, Main Campus on Tuesday 5th December 2023 at 2pm. Ten winners will be selected. One winner will be selected via a random number generator from UOW metro campuses, one from Wollongong campus and one from the regional campuses. One winner will then be selected via a random number generator from each of the four Faculties. The remaining winners will be selected via a random number generator from all available entries. A student can not win more than one prize during each promotion period. If the same student is selected, the prize will be redrawn.
7. **Notification:** The winners will be contacted via their UOW student email address.
8. **Prize:** The total value of the prize pool equals AUD\$500.00, and will consist of 10 x \$50.00 electronic gift cards. Prizes, or any unused portion of a prize, are not transferable or exchangeable and may not be redeemed for cash. All prizes are accepted entirely at the risk of the winner, and the Promoter excludes all warranties in connection with any prize to the extent permitted by law. The Promoter takes no responsibility for prizes damaged in transit. The Promoter reserves the right to substitute any prize with a prize of equal or greater value (including where the prize is unavailable for whatever reason), subject to approval of the gaming authorities in New South Wales, where required. Prizes have been confirmed in good faith and the Promoter cannot be held accountable for changes or withdrawals of prizes due to circumstances beyond its control.

The prize and/or any element of the prize must be taken as stated and cannot be varied by the winner. No compensation will be payable if the winner is unable to use their prize and/or any element of the prize as stated.
9. **Winners:** Where requested by the Promoter, the winners must provide evidence which, to the reasonable satisfaction of the Promoter, demonstrates that he or she is the winner, is eligible to enter, and has complied with these Terms and Conditions. Evidence that may be required by the Promoter includes either the winner's student ID card or drivers licence as proof of identity.
10. **Claiming prizes:** Prizes will be sent via email to the winners from 6 December 2023 at 9:00am AEST. All winners must acknowledge the winners notification and confirm and email address to which the prize will be sent.

11. **Unclaimed prizes:** Reasonable efforts will be made by the Promoter to contact any winners who do not respond to the winner notification. Winners who do not respond to the winner notification within two weeks will be withdrawn. Any prizes not claimed will be not be reallocated.
12. **Redraw of prizes:** No redraw of prizes will be conducted for this Promotion.
13. **Entries:** No responsibility is accepted by the Promoter for late, failed, incomplete or incorrectly entered entries or for partial or garbled computer transmissions or technical failures of any kind. The Promoter reserves the right to verify the validity of entries. Entries that are forged, incomplete, illegible, or do not comply with the Terms and Conditions will be deemed invalid.
14. **Record keeping:** The Promoter will retain all records relating to the Promotion for a minimum period of twelve (12) months following the claiming and/or withdrawing of all prizes.
15. **Promoter's decision final:** All decisions of the Promoter with respect to the matters referred to in these terms and conditions are final and no correspondence will be entered into, including in the event of a dispute.
16. **Liability and release:** The Promoter shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury, loss or damage suffered or sustained (even caused by negligence) in connection with accepting or using a prize or participating in this Promotion, except for any liability which cannot be excluded by law.
The Promoter is not responsible for defective prizes, lost or stolen prizes or misuse of any prize.
