3.1 Business from Student Advisory Council Committees

The Academic Senate Undergraduate representative provided an overview of their involvement on Careers and Employability Review and encouraged representatives to be involved in ongoing work occurring in the Review.

The Deputy Chair indicated that the StudentLife@UOW Steering Group had its final meeting and thanked the departing Deputy Vice Chancellor (Academic and Student Life) for their support.

PART 3: GENERAL BUSINESS





*3.1 Shoalhaven Campus Survey

The Chair invited Henry Altenburg, Shoalhaven Campus Representative to speak to this item.

They provided an overview of the Shoalhaven Campus Survey that they undertook to inform the delivery of activities on the Shoalhaven Campus. They indicated that there was a 79.7% satisfaction rating, with a desire for additional social and academic activities, particularly Peer assisted study.

The Director, Division of Student Life indicated that additional Peer Assisted Study Session would be offered to regional campus students and would be complemented by the Student Success Strategy. They congratulated the Shoalhaven Campus Representative on undertaking the survey.

- (ii) endorse the draft recommendations of the report; and
- (iii) approve the recommendations as the formal advice of the Council to be sent to the Delegated Authority for consideration,

*3.2 Clubs and Societies Review Update

The Chair invited Keval Patel and Melissa Zaccagnini to speak to this item. They provided an overview of the significant student and staff consultation that informed the recommendations of the working group.

The Clubs and Societies Review was initiated to ensure a vibrant, aspirational vision of clubs and societies at UOW, particularly following Covid-19. They provided an overview of the 5 key recommendation themes that emerged from the review and thanked all staff and students involved.

Draft resolution:

that the Student Advisory Council note Clubs and Societies Review Update provided by the Senior Manager, Student Experience and Projects and UOW Pulse Student Director.





*3.3 Student Success Strategy

The Chair invited Dr Kylie Austin, Associate Director, Student Equity and Success to speak to this item.

They provided an overview of the consultation that occurred to inform the development of the Strategy, leveraging perspectives from the Student Equity Working Group and International Experience Working Group.

The Strategy has five pillars for student success:

- 1. Supported Transition into and Through UOW;
- 2. Living, Health and Wellbeing;
- 3. Engagement with Learning;
- 4. Belonging and Connectedness;
- 5. Strong Sense of Purpose.

Several initiatives will be delivered as a result of the Strategy including:

- Equity, diversity and inclusion training for staff and students.
- A first-year mentoring program for all commencing students;
- Student monitoring, outreach, and engagement in support services through a dedicated retention team.
- Increased staffing and visibility of literacy and numeracy skills and study support.
- Launch of UOW's **financial** inclusion action plan, with increased access to emergency financial support, breakfast programs and initiatives that address placement poverty and food security.

They provided an overview of the Student Equity and Success unit structure.

The Clubs and Societies representative commended the work of the Strategy.

Draft resolution:

that the Student Advisory Council endorse the consultation of the Student Success Strategy to commence as provided in the agenda paper.

3.4 Building 19 Renovations and Move

The Chair invited Theresa Hoynes, Director, Division of Student Life to speak to this item. The Director, Division of Student Life provided an overview of moving Student Mental Health and Wellbeing Team into the ground floor of Building 19, with Student Associations moving to the first level of Building 11.
