# 2026 The Illawarra Connection, Sydney Business School, University of Wollongong Postgraduate Scholarship

## Terms and conditions

---

### 1. OVERVIEW

- a) I understand that The Illawarra Connection, Sydney Business School, University of Wollongong Postgraduate Scholarship consists of a tuition fee waiver of 100%, which will be applied directly to UOW tuition fees for the duration of my enrolment at the University of Wollongong.
- b) I understand that the Scholarship will be awarded for students commencing in 2026 only.
- c) I understand that the term of this Scholarship is for the normal duration of my degree as detailed in my offer letter.
- d) I understand that the University of Wollongong is sponsoring the Scholarship.
- e) I understand that this agreement is for the terms and conditions of the Scholarship only and is not an offer of accommodation or a UOW offer of admission.

### 2. ELIGIBILITY

I understand that to be eligible for the Scholarship I must:

- a) accept these terms and conditions. If I do not sign and return these terms and conditions I will not be eligible for the Scholarship;
- b) receive an offer for 2026 for a place in one of the following degrees offered by Sydney Business School, University of Wollongong:
  - Graduate Certificate in Applied Finance
  - Graduate Certificate in Business
  - Graduate Certificate in Business Administration
  - Graduate Certificate in Business Analytics
  - Graduate Certificate in Digital Marketing and Data Analytics
  - Graduate Certificate in Human Resource Management
  - Graduate Certificate in Innovation and Entrepreneurship
  - Graduate Certificate in Marketing
  - Graduate Certificate in Professional Accounting
  - Graduate Certificate in Project Leadership and Management
  - Graduate Certificate in Sustainable Supply Chain Management
- c) remain enrolled as a full time or part time student at the University of Wollongong for the duration of my degree program.

### 3. GENERAL OBLIGATIONS

- a) I understand that if there are any changes to my Faculty of enrolment or my pattern of study after I accept this Scholarship, I must notify the Support Officer via [bal-scholarships@uow.edu.au](mailto:bal-scholarships@uow.edu.au) within 14 days.
- b) I understand that this Scholarship offer is not deferrable
- c) I declare that I am not in receipt of any other Scholarship or sponsorship with any organisation for which my tuition fees, or part thereof, are paid to UOW on my behalf.
- d) I understand that this Scholarship offer applies only to the specific course (and major if relevant) as indicated in the attached offer letter. If I apply for a different course or transfer to a different course (or major if relevant), I understand that this Scholarship offer will no longer be valid. If my application for the new course is successful, I will be advised whether or not I will be awarded a Scholarship for the new course and will be required to accept and sign a new agreement.

### 4. PAYMENT

- a) I understand that the Scholarship is not redeemable for cash and is not transferable to any other costs.
- b) I understand that the scholarship will cover any increased tuition fee as a result of the UOW variable fees policy and I am responsible for any additional student fees that are not tuition fees.

### 5. TERMINATION

- a) I understand that failure to meet any of these conditions may result in:
  - i. the tuition fee waiver will be removed
  - ii. me being responsible to repay to the University of Wollongong an amount equal to the Scholarship. The University may withhold my academic results and documents until this payment is received.
- b) Following the award of this Scholarship, if the University obtains additional information about my academic background which would require a re-assessment of my original application for admission and Scholarship, the Scholarship may be withdrawn.
- c) I understand that once my Scholarship is terminated it cannot be reinstated at a later date.
