

UNIVERSITY OF WOLLONGONG (UOW)

2024 RECONNECT PROMOTION –

TERMS AND CONDITIONS

Entry into the University of Wollongong (UOW) 2024 Reconnect Promotion (“**Promotion**”) is deemed to be an acceptance of the following terms and conditions. Entries must comply with these terms and conditions to be deemed a valid entry.

1. **Promoter:** University of Wollongong (ABN 61 060 567 686) of Northfields Avenue, Wollongong, NSW, 2522.
2. **Promotion Period:** The Promotion will run from 15 November 2024 at 9:00 am AEST to Friday 20th December 2024 at 3:00 pm AEST.
3.
Eligible entrants
 - 3.1. Entry is open to eligible persons who enter the Promotion in the valid form as outlined at clause 4 below (**Entrant**).
 - 3.2. Eligible persons are Australian residents, over 18 years old and are former graduates of the University of Wollongong. This excludes graduates from UOW College Australia, Dubai and Hong Kong.
 - 3.3. The Promoter’s directors, management, employees and their immediate families are ineligible to enter together with parents of students, careers advisers, agencies and suppliers associated with this Promotion are ineligible to enter.
4. **Entry:**
 - 4.1. To enter the Promotion, eligible persons must, during the Promotion Period:
 - 4.1.1. read and agree to these terms and conditions of the Promotion; and
 - 4.1.2. update their details via the lead-gen form on Meta, LinkedIn or via [Update Your Details Webpage](#)
 - 4.2. Entry is limited to one entry per person only.
 - 4.3. Entries are deemed to be received at the time of receipt by the Promoter and not at the time of transmission or deposit by the Entrant. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.
 - 4.4. No responsibility is accepted by the Promoter for late, failed, incomplete, or incorrectly entered entries or for partial or garbled computer transmissions or technical failures of any kind.
 - 4.5. The Promoter reserves the right to verify the validity of entries (including an Entrant's identity, age and place of residence). Entries that are forged, incomplete, illegible, or do not comply with these terms and conditions will be deemed invalid. In the event that a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered.
 - 4.6. The Promoter reserves the right to disqualify entries in the event of non-compliance with these Terms and Conditions.
 - 4.7. The Entrant is responsible for any costs associated with entering the Promotion. Examples of such costs include, but are not limited to, the costs associated with accessing the internet by the Entrant or phone bills charged to the Entrant by the Entrant’s telecommunications provider.

5. Prize:

- 5.1. The total value of the prize equals AUD \$1,000.00.
- 5.2. The prize consists of one \$AUD1,000.00 visa gift card.
- 5.3. Entrants acknowledge that in order to claim and subsequently use the prize, they will be required to comply with UOW's policies and procedures, as well as any applicable laws
- 5.4. In the event that a winner fails to comply with these specific requirements, the winner acknowledges that they may forfeit the remaining benefit of the prize.
- 5.5. The prize and/or any element of the prize must be taken as stated, and cannot be varied by the winner. No compensation will be payable if the winner is unable to use their prize and/or any element of the prize as stated.
- 5.6. The prize, or any unused portion of a prize, are not transferable or exchangeable, and may not be redeemed for cash.
- 5.7. The Promoter reserves the right to substitute any prize with a prize of equal or greater value (including where the prize is unavailable for whatever reason), subject to approval of the gaming authorities in NSW, where required. The prize have been confirmed in good faith and the Promoter cannot be held accountable for changes or withdrawals of the prize due to circumstances beyond its control.
- 5.8. The Promoter accepts no responsibility for any variation in prize value (including between advertising of the Promotion and receipt of the prize).
- 5.9. The prize is accepted entirely at the risk of the winner, and the Promoter excludes all warranties in connection with any prize, to the extent permitted by law.
- 5.10. The Promoter takes no responsibility for any prize damaged in transit, and is not responsible for defective prize, lost or stolen prize, or misuse of the prize.
- 5.11. The Prize is subject to the full terms and conditions governing the use of visa gift card located at [the BHN Corporate store website](#). Prize will be valid until expiration date printed on the front of the card and can be used in any store in Australia or overseas or for internet purchases where VISA prepaid cards are accepted, provided the merchant can process it electronically. Visa Gift Cards cannot be used for mail or telephone orders or at ATMs

6. Selection of winners:

- 6.1. The winner of the prize will be selected out of the pool of eligible Entrants who have entered the Promotion in the valid form as outlined at clause 4.
- 6.2. The selection of the winner will be conducted via a random number generator. The first valid entry drawn will win the prize.
- 6.3. The selection of the winner will be held at the Promoter's Advancement and Communications Division (located in Building 39B, University of Wollongong, Wollongong, NSW, 2522) on 10 January 2025 between 10:00 am and 3:00 pm AEST.

7. Notification of winners:

- 7.1. The winners will be contacted in writing by the Promoter via any of the contact methods provided in their entry on 10 January 2025 between 10:00 am and 3:00 pm AEST.

8. Identification of winners:

- 8.1. Where requested by the Promoter, the winners must provide evidence which, to the reasonable satisfaction of the Promoter, demonstrates that they are the winner, were eligible to enter the Promotion, and has complied with these terms and conditions.
- 8.2. For the purposes of public statements and advertisements, the Promoter may only publish the winner's name and State/Territory or postcode of residence at 10:00 am on 10 January 2025 on Facebook (Facebook page name: UOW: University of Wollongong, Australia).

9. Claiming of the prize:

- 9.1. The winner will be informed how to claim their prize during the notification process outlined at clause 7 above.

10. Unclaimed prize:

- 10.1. Reasonable efforts will be made by the Promoter to contact the winner who does not respond to the notification outlined at clause 7 above.
- 10.2. The Winner who does not respond to the notification by 17 January 2025 AEST will have their prize withdrawn without further notice.
- 10.3. If the prize is not claimed and subsequently withdrawn by the Promoter, it will be reallocated via a redraw pursuant to clause 44 below.

11. Redraw of the prize:

- 11.1. Previous winner of the prize in this Promotion are ineligible to claim the prize.
- 11.2. Redraw of a prize will occur in the same manner as outlined at clause 6 above, and notified via any of the contact methods provided in their entry.
- 11.3. The redraw of a prize will occur on 31 January 2025 between 10:00 am and 3:00 pm AEST, with the subsequent winner to be contacted on 31 January 2025 between 10:00 am and 3:00 pm AEST.
- 11.4. Reasonable efforts will be made by the Promoter to contact the redraw winner who does not respond to the notification outlined at clause 7 above.
- 11.5. Redraw winner who do not respond to the notification by 7 February 2025 at 9:00 am AEST will have their prize withdrawn without further notice.
- 11.6. Any redrawn prize not subsequently claimed will not be further reallocated.

12. Promoter's decision:

- 12.1. If there is a dispute about the conduct of the Promotion (including the identity of a winner), the decision of the Promoter is final and binding on each Entrant and no correspondence will be entered into.

13. Liability and release:

- 13.1. The Promoter shall not be liable for any loss or damage whatsoever which is suffered (including, but not limited to, indirect or consequential loss) or for any personal injury, loss or damage suffered or sustained (even if caused by negligence) in connection with participating in the Promotion or accepting or using a prize, except for any liability which cannot be excluded by law.
- 13.2. If, for any reason, the Promotion is not capable of running as planned, the Promoter reserves the right in its sole discretion to cancel, terminate, modify or suspend the Promotion, subject to any directions from a regulatory authority.
- 13.3. All Entrants release from, and indemnify the Promoter against, all liability, cost, loss, or expense arising out of acceptance of any prize(s) or participation in this Promotion including (but not limited to) personal injury and damage to property and whether direct or consequential, foreseeable, due to some negligent act or omission or otherwise.
- 13.4. Any guarantee or warranty given is in addition to any relevant statutory guarantees and warranties and nothing in these Terms and Conditions restricts, excludes or modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the *Competition and Consumer Act 2010* (Cth).
- 13.5. The Promoter accepts no responsibility for any tax implications and the Entrant must seek their own independent financial advice in regards to the tax implications relating to the prize or acceptance of the prize.

14. Privacy:

- 14.1. UOW is committed to protecting the privacy of Entrants and winners. - 14.2. The Promoter may use this information for future marketing purposes regarding its products, services, including contacting the Entrant electronically. The Promoter collects personal information about Entrants to enable them to participate in this Promotion and may disclose the Entrants' personal information to third parties including its contractors and agents, prize suppliers and service providers to assist in conducting this Promotion and to the State and Territory lottery departments as required under the relevant lottery legislation. If the Entrant does not provide their personal information as requested, they may be ineligible to enter or claim a prize in the Promotion.
- 14.3. By entering the Promotion, all Entrants acknowledge that the Promoter will use and disclose the Entrant's personal information to the extent required to conduct the Promotion, including identifying Entrants, verifying, assessing, and judging the entries, and issuing the prize.
