## UNIVERSITY OF WOLLONGONG CONSENT MATTERS TRADE PROMOTION – TERMS AND CONDITIONS

Entry into the University of Wollongong Consent Matters Trade Promotion (“**Promotion**”) is deemed to be an acceptance of the following terms and conditions. Entries must comply with these terms and conditions to be deemed a valid entry.

1. **Promoter:** The Promoter is University of Wollongong (ABN 61 060 567 686) of Northfields Avenue, Wollongong, NSW, 2522.
2. **Promotion Period:** The Promotion will run from 1 January 2026 to 13 April 2026.
3. **Eligibility:** Eligible persons include UOW current students who have enrolled at UOW for the first time in Autumn Session 2026 (**Entrant**). The Promoter’s employees, management, contractors, and their immediate families are ineligible to enter the Promotion.
4. **Entry:** To enter the Promotion, the Entrant must, during the Promotion Period, complete the UOW Consent Matters module via Moodle. Entry into the Promotion will be automatic upon successful completion of the UOW Consent Matters module, unless an eligible person otherwise opts out of the Promotion prior to the end of the Promotion Period. Entry is limited to one entry within the Promotion Period.
  - a. No responsibility is accepted by the Promoter for late, failed, incomplete, or incorrectly entered entries or for partial or garbled computer transmissions or technical failures of any kind.
  - b. The Promoter reserves the right to verify the validity of entries. Entries that are forged, incomplete, illegible, or do not comply with these terms and conditions will be deemed invalid.
  - c. The Entrant is responsible for any costs associated with entering the Promotion. Examples of such costs include, but are not limited to, the costs associated with accessing the internet by the Entrant or phone bills charged to the Entrant by the Entrant’s telecommunications provider.
5. **Prizes:** The total value of the prize pool equals AUD\$400, made up of four (4) prizes of 4 x \$100 UOW Pulse gift voucher.
  - a. Prizes, or any unused portion of a prize, are not transferable or exchangeable, and may not be redeemed for cash.
  - b. All prizes are accepted entirely at the risk of the winner, and the Promoter excludes all warranties in connection with any prize to the extent permitted by law. UOW takes no responsibility for any prize damaged in transit. The Promoter is not responsible for defective prizes, lost or stolen prizes or misuse of any prize.
  - c. The Promoter reserves the right to substitute any prize with a prize of equal or greater value (including where the prize is unavailable for whatever reason), subject to approval of the gaming authorities in NSW, where required. Prizes have been confirmed in good faith and the Promoter cannot be held accountable for changes or withdrawals of prizes due to circumstances beyond its control.

- d. The prize(s) and/or any element of the prize must be taken as stated and cannot be varied by the winner. No compensation will be payable if the winner is unable to use their prize and/or any element of the prize as stated.
6. **Selection of winner(s):** The winner(s) of the prize(s) will be selected out of the pool of Entrants who have entered the Promotion in the valid form as outlined at clause 4. The selection of the winner will be via random number generator. The selection of the winner(s) will be held at the Promoter's Office, Integrity Division, Safe & Respectful Communities, Building 19, Northfields Avenue, University of Wollongong on Monday 13th April 2026 at 9am.
  7. **Notification of winner(s):** The winner(s) will be contacted via their UOW student email address.
  8. **Identification of winner(s):** Where requested by the Promoter, the winners must provide evidence which, to the reasonable satisfaction of the Promoter, demonstrates that they are the winner, were eligible to enter the Promotion, and has complied with these terms and conditions.
  9. **Claiming of prizes:** The prizes will be available for the winners to collect or arrange collection between Monday 13th April 2026 and Friday 1st<sup>th</sup> of May 2026. The winner must provide the identification required under clause 8 above in order to receive their prize.
  10. **Unclaimed prizes:** Reasonable efforts will be made by the Promoter to contact any winner who does not respond to the notification outlined at clause 7 above. Winners who do not respond to the notification by Friday 1st of May 2026 will be withdrawn without further notice.
  11. **Record keeping:** The Promoter will retain all records relating to the Promotion for a minimum period of three (2) months following the claiming and/or withdrawing of all prizes.
  12. **Promoter's decision:** All decisions of the Promoter with respect to the matters referred to in these terms and conditions are final, and no correspondence will be entered into, including in the event of a dispute.
  13. **Liability and release:**
    - a. The Promoter shall not be liable for any loss or damage whatsoever which is suffered (including, but not limited to, indirect or consequential loss) or for any personal injury, loss or damage suffered or sustained (even if caused by negligence) in connection with participating in the Promotion or accepting or using a prize, except for any liability which cannot be excluded by law.
    - b. If, for any reason, the Promotion is not capable of running as planned, the Promoter reserves the right in its sole discretion to cancel, terminate, modify or suspend the Promotion, subject to any directions from a regulatory authority.
    - c. All entrants release from, and indemnify the Promoter against, all liability, cost, loss or expense arising out of acceptance of any prize(s) or participation in this Promotion including (but not limited to) personal injury and damage to property and whether direct or consequential, foreseeable, due to some negligent act or omission or otherwise.
