PERIOD OF INSURANCE:	31 December 2019 to 31 December 2020
PERIOD OF COVER:	Cover under this Policy shall only apply whilst the Insured Person is engaged on Travel during a Policy Period, as defined: TRAVEL means travel undertaken on the business of the Insured which is authorised by the Insured and shall include associated leisure travel provided always such travel involves a destination outside a radius of 50 kilometres from the place of departure for the commencement of the Travel excluding everyday travel to and from the Insured Person's place of business. TRAVEL automatically extends to provide cover for Spouses and/or Dependant Children departing after the Insured Person who are travelling directly to join and remain with the Insured Person for the remainder of the Travel. It shall also provide cover for Spouses and/or Dependant Children who have been travelling with the Insured Person but are departing to returning directly to Australia before the Insured Person. TRAVEL also means personal or non-associated leisure travel for Directors, Chief Financial Officer, Chief Executive Officer, Chief Operating Officer, Company Secretary and Nominated (Named) Executives and their accompanying Spouse and Dependant Children provided always such travel involves: - a flight or pre-booked overnight stay, - an Interstate destination, or - a destination outside Australia. Cover commences from the time the Insured Person leaves his or her normal residence or place of business, whichever is the place of departure for the commencement of the Travel and continues for a maximum period of; - 365 consecutive days in respect of business travel trips - 42 consecutive days in respect of personal or non – associated leisure travel trips Or until the Insured Person returns to his or her normal residence or place of business, whichever occurs first. Section 3.1 Loss of Deposits shall commence at the time the Insured Person pays in part or full for the Travel.
